Nikki Richardson is a lifelong KCK resident. She attended Sumner Academy of Arts & Science and holds a Marketing B.S.A from Ottawa University. After leaving a previous career in operations and project management, she has spent the last four years utilizing her range of skillsets to help reform and improve her hometown, through intentional nonprofit work. She has been a successful campaign manager for the past three years, achieving historic wins that improve diversity in local government and the criminal justice system for Wyandotte County. She has demonstrated incredible knack for strategically navigating complex relationships and working with critical and difficult stakeholders to effect significant changes in Kansas City, KS. Her talents are being utilized to help our

organization build a strong foundation and continue to chart the strategic path to grow Justice for Wyandotte from a grassroots group to a trusted organization for education, empowerment, and reform.

Nikki Richardson spearheaded creation, production, and hosting of the 7th Street Podcast to provide a safe space for victims in her community to share their stories. The podcast garnered attention from RocNation investigators, inspiring additional coverage of the Golubski case such as KCUR 89.3's "Overlooked." She onboarded a therapist to address victim trauma and actively pursues strategic partnerships to enhance mental health resources for comprehensive client support. Instrumental in securing additional funding post-incorporation, she maximizes resources to expand our services across Kansas City, KS, and amplifies fundraising efforts to address broader community needs. In the past year, she succesfully organized the Release the Footage rally, drawing attention to systemic issues surrounding officer-involved shootings and access to body camera footage, notably in the case of Amaree'ya Henderson's tragic shooting. She was key in John Anderton's family ability to access to body camera footage in 2023, sparking a fundraising campaign for belts, symbolizing the stark reality of KCK's use of force policy.

Khadijah Hardaway has been an activist since the age of five. She served as Alvin Sykes' executive assistant from 2003 to 2007, aiding in passing critical legislation such as the Till Bill. Currently, she serves as the social action chair for Grant Chapel AME and is Gamelial-certified in social justice organizing. In 2017, Khadijah became an advocate for marginalized and underserved women allegedly sexually assaulted and murdered by former KCK Detective Roger Golubski. She played an integral role in urging victims to share their stories, accompanying many to meetings with lawyers and FBI investigators. Khadijah is passionate about helping individuals understand their legal rights and referring them to life resources to sustain themselves through the legal process.

As a survivor of sexual assault and police brutality, Khadijah intimately understands the feelings of powerlessness and the challenges posed by limited resources within the system. Following her leadership training in social justice organizing, her purpose and mission became more defined. Her journey through adversity has illuminated a pathway to truth and justice, enabling her to express herself and offer healing to others through various artistic gifts.

Khadijah helped lead the charge for John



he did not commit 18 years ago. She also led the efforts to reopen the case of Sameemah T. Musawwiir, also known as Pearl Davis, who was a dear family friend. This case heightened her awareness of many other unsolved murders of women allegedly associated with corrupt KCK law enforcement officers. Khadijah played a key role in organizing rallies to demand a full investigation of Roger Golubski. She was also a vocal advocate for the resignation of Golubski's former partner, KCKPD Chief Terry Zeigler and pushed for community input in the appointment of his replacement. Her current contributions are focused on conflict resolution and trauma training, empowering other organizations with the tools to support and sustain communities in need.



Dr. Sheryl Stewart is a lifelong educator and learner with a career in public education, primarily as an English teacher at Chrisman High School in Independence, Missouri. Her career has been followed by a fulfilling role in language and curriculum development and implementation at Central Baptist Theological Seminary. She is a graduate of UMKC, the University of Louisville, and the University of Kansas, and has pursued including additional training Gamaliel leadership, Auburn justice ministries, and Buttry Center conflict transformation training of trainers.

Sheryl learned early that the narrative heard depends on who has been allowed to speak, and she has always sought ways to broaden perspectives with more diverse


voices. She volunteered as a facilitator for Kansas City Harmony, REACH, and Anytown. She also organized students in her classroom who advocated for improved conditions in their school. Dr. Stewart's faith has informed her passion for justice, starting with openness and fairness to all and leading to efforts to disrupt systems that exclude and oppress. She is committed to being a strong ambassador for Justice for Wyandotte and is constantly seeking opportunities to connect Justice for Wyandotte with other organizations.

Dr. Stewart has actively shared and encouraged the vision for Justice for Wyandotte as it evolved—from assisting in organizing rallies and strategy meetings since 2020, to facilitating the filing for incorporation and tax-exempt status in 2021, to providing financial support over the past three-plus years. She finds particular fulfillment in being part of a multi-generational, multi-racial team of brilliant women, where she can both offer and receive support, discernment, and perspective. Her primary goal is to enhance name recognition and increase the number of monthly donors to Justice for Wyandotte. A robust budget will enable the organization to initiate more initiatives aimed at achieving the sustainable. equitable community that Justice for Wyandotte envisions.

## **Our Beginnings**

**2020** - Before the establishment of Justice for Wyandotte as an official nonprofit organization, we were a collective of impassioned individuals who participated in rallies during the summer of 2020. Our attention was drawn to the disturbing trend of sexual harassment and the tragic deaths of multiple Black women, all linked to a corrupt detective within the KCKPD, Roger Golubski. It was evident that these issues were being overlooked. This concern was what forged us together with a mission to find ways to raise awareness.

Our collaborative efforts resulted in impactful initiatives, including a Women's Empowerment event and the creation of *The 7th Street Podcast*, providing a platform for victims and their families to share their stories comfortably. Recognizing the risks of exploitation when Black stories are not authentically represented by Black voices, we committed to rectifying this unfortunate and common disparity. We made the decision to formalize our group as a nonprofit to help further our mission to restore and reform Wyandotte County over the next year. Thus, the journey of Justice for Wyandotte and our mission began.



**2021** - In 2021, our primary focus was on achieving incorporation and shedding light on unsolved homicides, particularly the absence of a dedicated cold case unit in Kansas City, Kansas. Through a potent social media campaign, we highlighted actively cases we monitored, connecting with more affected family members. deepened our advocacy, we quickly recognized the crucial need for mental health resources.

Recognizing this, Justice for Wyandotte assisted a Golubski-survivor, Niko Quinn

in starting the Spiritual Sister Circle, providing trauma victims a platform for connection and essential mental health support. During this time, *The 7th Street Podcast* gained traction, reaching investigators, journalists, and producers from out of town.

Throughout the year, we celebrated two significant victories. Firstly, we secured a commitment for the establishment of a cold case unit by the KCKPD in 2022. Additionally, we received news of the FBI's arrest of Roger Golubski, marking a pivotal moment in our ongoing pursuit of justice.

2022 - In January 2022, we attained 501c3 status and commenced fundraising efforts crucial for expanding advocacy and compensating our organizers. At the onset of the year, the Kansas City Kansas Police Department fulfilled its promise and began investigating cases under its new cold case unit.

In March, we partnered with Strom Law Firm for an informative breakfast at Loews Hotel, addressing victims of police misconduct. After understanding the trauma of the victims we were meeting, we also began project planning for proposed mental health support initiatives for community violence victims, advancing two potential projects.

Our efforts this year also included observing gaps in legislation surrounding sexual assault committed by law enforcement officers and starting discussions with elected officials about potential solutions for reform.







### **A Year in Review**

2023 - In partnership with the Wyandot Behavioral Health Center, we launched our inaugural healing circle session to provide psychoeducation on coping with trauma and grief. During this process, we identified internal and external barriers to continuous mental health treatment, including cultural stigma and logistical challenges like childcare and transportation.

To address these obstacles, we shifted our focus to offering scholarships for therapy expenses during our advocacy initiatives. We are actively seeking partnerships with mental health organizations to enhance access to affordable and accessible professionals and programs.




Two cold cases we actively advocated for, Christina King and Sameemah Mussawiir (Pearl Barnes), were successfully resolved under the newly established KCKPD cold case unit. Throughout the year, we assisted two new families in reviewing body cam footage related to fatal officer-involved shootings and organized a tri-county rally to raise awareness about accessing information in police violence cases across the metro.

Justice for Wyandotte also hosted educational and memorial event at the Legends Field for the historic Kansas City Monarchs, highlighting gaps in the open records request process and advocating for compassion durina officer-involved shootings. This event connected elected officials and legal professionals with the impacted families to talk about these critical issues. At the end of year, Justice for Wyandotte was happy to secure a coworking office space in downtown Kansas City, KS, providing a foundation and network for our future growth.

## Financial Review



We conducted a thorough financial review of our expenses to determine how much of our overall budget was used for advocacy and reform efforts, extending our reach, education initiatives, and general costs. This operating process transparency ensures and accountability in how we allocate resources, enabling us to effectively advance our mission and maximize impact in our community.

Our total cost of expenses to help support our mission in 2023 was \$42,634.28. Our proposed budget for 2024 is \$44,315.00.

#### **Advocacy & Reform Efforts - 1%**

Our advocacy and reform efforts range from grassroots organizing and community mobilization to lobbying policymakers and engaging in public education campaigns. It encompasses protests, petitions, and social media activism, leveraging diverse platforms to shine a light on issues and mobilize support for change. Justice for Wyandotte is unique in the fact that we consider wellness and mental health care one of the key cornerstones of our advocacy work.

Although advocacy and reform made up a very small portion of our budget it was not a small portion of our work. Every step of the way we were able to find cost effective ways to meet our objectives. Justice for Wyandotte, Inc. was grateful to partner with certified therapist Dorathy Scott and Wyandot Behavioral Health in launching a pilot group psychoeducation program for those impacted by community violence.



Through this program, participants were provided the opportunity to engage in therapeutic discussions, learn coping strategies, and foster resilience in the face of adversity. partnership aligned with our commitment to holistic advocacy and prioritizing mental health in our pursuit of justice and healing. This project has evolved scholarship-based to а program for clients we support that are in need.

We are consistently committed to fostering meaningful dialogue by organizing rallies and events that connect community members with elected officials. Among these initiatives, the Release the Footage rally stood out as a powerful call for transparency and justice in officer-involved shootings across the Kansas City metro. Through this event, we brought together concerned citizens and activists from organizations across city and county lines to demand the release of crucial evidence and uphold transparency in law enforcement practices.

Additionally, we hosted a special birthday event to commemorate the lives of John Anderton and Amaree'ya Henderson whose birthdays were just one day apart. We invited local officials and legal professionals to this event to listen to a comprehensive presentation on the concerning increase in officer-involved shootings and shedding light on the lack of victims' services for victims and their families after experience police violence and the inadequate description of family under Kansas's current open records act.

#### Advocacy & Reform Efforts (cont.) - 1%

These initiatives, rallies, and events serve as vital platforms for community engagement, empowering individuals to voice their concerns, share experiences, and demand accountability from elected representatives and law enforcement. We seek to continue to foster dialogue and collaboration between community members and officials and remain steadfast in our desire to promote justice, transparency, and positive change in our community.

### **Extending Our Reach - 12%**

Justice for Wyandotte is proud to expand its network and forge partnerships with esteemed organizations beyond state borders. Through collaborative efforts with the Milwaukee Alliance Against Racial Policing and Repression, as well as their national chapter in Chicago, IL, we amplify our collective voice in advocating for racial justice and police accountability on a broader scale.

Furthermore, our connection with the Emmett Till family and the organizers of the Let the World See exhibit has opened doors to impactful collaborations. As a result, we are proud to announce our official partnership with the University of Kansas to contribute to the Let the World See Exhibit in Lawrence, KS in 2024, This powerful exhibit will enlighten Kansas communities on the urgent need for systemic change.

#### **General Support - 87%**

We are thrilled to announce that Justice for Wyandotte, Inc. has secured office space at The Stables, nestled near downtown Kansas City, KS. This milestone marks a significant step forward in our mission to advocate for justice, equity, and accountability in our community. Justice for Wyandotte also took steps to formalize their financial processes and contracted with Exclusive Tax and Financial services for monthly accounting and bookkeeping of donor funds.

As we embark on this new chapter, we emphasize the critical importance of general support in sustaining our work and empowering the voices of Black women who lead the vision for Justice for Wyandotte, Inc. Contributions directly support the salaries of these dedicated individuals, allowing them to continue spearheading our initiatives, amplifying marginalized voices, and driving positive change.





Justice for Wyandotte is honored to maintain an ongoing relationship with the Department of Justice, a partnership that underscores our goals to promoting tangible solutions that promote healing and wellness in our community. Through this collaboration, our lead organizer, Khadijah Hardaway, has received specialized conflict resolution training at zero cost to our organization, equipping her with invaluable tools to address the complex needs of individuals affected by injustice and trauma.



Building upon this foundation, Justice for Wyandotte is proud to announce our partnership with Ahmad's Justice and support from the Department of Justice to offer conflict resolution training to communities across the Kansas City metro area. This initiative aims to empower individuals and communities with the knowledge and skills needed to recognize, address, and heal from conflict. By extending this training to diverse communities, we aspire to foster a culture of compassion, understanding, and support for those navigating the effects of violence and injustice.

### Community Education & Training (cont.) - 0%

Justice for Wyandotte also collaborates with the Diversity, Equity, and Inclusion team at Wyandotte High School. This partnership was fostered by Nikki Richardson and has begun generating awareness and understanding among Kansas City, KS educators about the impacts of weaponized whiteness in their local community. Through educational presentations, she helps facilitate crucial conversations about how classroom dynamics and the broader community may be influenced by these issues.

This work aims to equip educators with the knowledge and tools needed to create inclusive and supportive learning environments for all students, particularly those affected by systemic inequities. By addressing the nuances of weaponized whiteness, it empowers educators to recognize and challenge bias, promote cultural sensitivity, and advocate for equity in education. Through ongoing collaboration with the Diversity, Equity, and Inclusion team, we have become locally rooted in meaningful change and promoting social justice within the educational landscape of Kansas City, KS.
